**Equipment Requirements:**

- Vendors must provide all canopies, tables and chairs. We will not have any available to rent.
- If you purchase electricity it will be provide through a 20 amp electric circuit
- You must provide all signage for the booth.

**Business License:**

All Greenwood Classic Car and Hot Rod food vendors must have a current Washington State Business License through June 24, 2006.

**Tax Information: Washington State**

The Washington State Department of Revenue has been diligent in enforcing sales tax laws. State Auditors have been known to attend festivals and special events to confirm that vendors are properly licensed and are conforming to tax laws. **Health Department:**

The Health Department is a vital part of the Car Show and we depend on their expertise and concern for the public safety. The Greenwood Classic Car and Hot Rod completely supports the Health Department in all matters regarding sanitation and public health at the Car Show. Each vendor must obtain the appropriate health and propane permits from the Health Department. You cannot operate a food booth at the Car Show without a health permit issued specifically for this event. The Health Department also requires Food Handlers Permits for all your staff.

**Insurance:**

Please arrange with your insurance carrier for a Certificate of Insurance in the amount of \$1,000,000 naming the Greenwood Chamber of Commerce, Greenwood Car Show, City of Seattle as "additional insured parties".
